## ADDRESSING THE CURRENT PROBLEMS AND CHALLENGES OF COHERENCE BETWEEN THE ACTORS INVOLVED IN PEACEBUILDING AND CONFLICT PREVENTION

# HIGHLIGHTING THE ECONOMIC DIMENSION OF CONFLICT PREVENTION AND PEACEBUILDING THROUGH THE ROLE OF THE PRIVATE SECTOR, AND LINK WITH THE ECONOMIC DIPLOMACY

The economic dimension of conflict needs to be addressed in order to explore the important role played by the private sector. In that sense, private sector can be considered as a conflict or/and peace driver as well. Beyond that, the role of the private sector on conflict prevention and peacebuilding might be taken into consideration in the new reflection on the EU economic diplomacy.

#### ISSUES TO BE ADDRESSED:

- Is the economic dimension of conflict taken into consideration by the EU in its external action?
- How the role of private sector could be apprehended as a peace conflict and peace driver?
- What are the potential links between this reflection on private sector and the new concept of EU economic diplomacy?
- To what extent partnerships between the EU and the private sector are possible and useful?
- How can economic diplomacy improve the action of the EU in terms of peacebuilding and conflict prevention?
- Can economic diplomacy be a path for coherence among the EU institutions and policies?
